Item 4 Marvin Jones Hollister, CA

Mr. Jones commented on how he has observed an average of one passenger or less on County Express buses on Friday afternoons while at the corner of San Benito Street and 4th Street. Mr. Jones stated that the fairbox recovery has improved slightly from less than 15% one year ago to 20% currently.

9. Approve Public Transit Modernization Improvements and Service Enhancement Account Project List for Fiscal Year 2008/2009 – LiOwen

Ms. LiOwen reviewed the list of eligible projects that were compiled by staff. At the Social Services Transportation Advisory Council meeting January 27, 2012, two projects were upgraded to a priority project.

Ms. Rheinheimer stated that the Board had valid questions and concerns and noted that staff would be able to report back to the Board noting which items will be locally sourced projects.
