6. Approve Contract between the San Benito County Local Transportation Authority (LTA) and Majic Consulting Group in the Amount not to Exceed \$79,981 for the Preparation of the San Benito County Transit Plan – Lezama

Ms. Lezama reported that the LTA received three proposals from qualified consultants for the preparation of the San Benito County Transit Plan. The Transit Plan will include short and long range recommendations to improve County Express and Jovenes de Antaño transit services.

Staff recommended that the LTA award the contract to Majic Consulting Group for the preparation of the San Benito Transit Plan.

Ms. Lezama mentioned that the Board of Directors will receive project updates throughout the development of the Transit Plan to ensure optimal feedback. In addition, the Social Services Transportation Advisory Council (SSTAC) will serve as the review committee–providing ongoing feedback throughout the development of the Plan. The general public will also have various opportunities to provide input on the service needs and project recommendations.

There was brief discussion about the proposal scores.

Director De La Cruz commended staff for including the three competitors in the staff report.

Upon a motion duly made by Director De La Cruz, and seconded by Director Boch, the Directors unanimously approved Item 6. Vote 4/0 Motion passes.

7. Approve Agreement between the Local Transportation Authority and the San Benito Health Foundation for the Construction and Installation of a Bus Stop Shelter – Rheinheimer

Ms. Rheinheimer asked to continue this item to a later date, possibly October's meeting.

Chair Botelho continued Item 7 to a future meeting date.

Upon a motion made by Director Gomez, and seconded by Director De La Cruz, the Directors unanimously voted to adjourn the LTA meeting.
