Subject: Low Carbon Transit Operations Program

#### **Recommendation:**

**ADOPT** Resolution 2016-01 to be eligible to receive Low Carbon Transit Operations Program (LCTOP) funds

#### Summary:

The Low Carbon Transit Operations Program provides funding for transit services that reduce greenhouse gas emissions. The LTA is proposing to use the funds to add additional transit services to the County Express system.

#### **Financial Considerations:**

\$56,513 is earmarked for San Benito County LTA

#### Background:

The Low Carbon Transit Operations Program (LCTOP) is one of several programs that are part of the Transit, Affordable Housing, and Sustainable Communities Program established by the California Legislature in 2014 by Senate Bill 862 (SB 862). The LCTOP was created to provide operating and capital assistance for transit agencies to reduce greenhouse gas emissions and improve mobility, with a priority on serving disadvantaged communities. Approved projects in LCTOP will support new or expanded bus or rail services, expand intermodal transit facilities, and may include equipment acquisition, fueling, maintenance and other costs to operate those services or facilities, with each project required to reduce greenhouse gas emissions.

#### Staff Analysis:

The State is requiring local agencies adopt a new resolution in order to be eligible to receive funds for LCTOP Projects. LTA Staff is pursuing funding for an "Intercounty Service Expansion" project. This project will provide more transportation options for people traveling between San Benito and Santa Clara Counties.

- Project Name: Expanded Intercounty Services
- Amount of LCTOP funds requested: \$56,513
- Short Description of project: The San Benito County LTA will increase the frequency of buses traveling from San Benito County to Gilroy (CalEPA identified Disadvantaged Community).
   This increase in transportation options may facilitate a decrease in single occupant vehicles from San Benito County in Gilroy.
